#### **Recreation Committee**

<u>Proposal for shelter on Interurban Trail</u>: Park advocates Greg Feeny and Joel Johnson presented a plan to construct a small shelter along the Interurban Trail (10 foot X 10 foot). The location of the proposed shelter will be on the West side of the Trail, South of Interstate 72 and North of Woodside Rd. Preliminary designs for the shelter were shared with the Board and are attached. Greg and Joel are working with the Parks Foundation to secure funding.

#### **Committee of the Whole**

<u>IGA regarding Leland Summer Kitchen</u>: Executive Director Harms provided an update on the relocation of the Leland Summer Kitchen. This is a complex project involving three municipal agencies and private contractors. The targeted move date is March 2. Harms also presented a draft IGA with the City of Springfield that describes the responsibilities of each party. Staff recommends the Board take action on the IGA next week.
